## *Fraud Alert Form*



Place a fraud alert on your credit files by making a single call to one of the fraud assistance numbers listed below. The credit agency that you call will share the information with the other two companies. The fraud alert will remain in place for approximately three months. **You must make a written request to the companies in order for the alert to remain in place for several years.** See the sample letters.

A complimentary copy of your credit report will be sent to you when a fraud alert is placed on your credit file, with a maximum of one report per year from each company.
