LCSO SPIDER Unit had a Busy Day

Yesterday, around 3 P.M., the Leon County Sheriff's Office Special Projects Investigations Detection Enforcement Response (S.P.I.D.E.R.) Unit conducted a traffic stop on Capital Circle N.W. near I-10 for a moving violation. Deputies found the driver of the vehicle, John O'Callaghan, did not have a valid driver's license.

LCSO K9 Deputy Casey Skelton responded to the traffic stop and K9 Maverick gave a positive alert to illegal narcotics after sniffing around the car.

Inside the vehicle deputies found about five ounces of Methamphetamine, Cannabis, and drug paraphernalia. O'Callaghan and his passenger, Brenda Ward, were both arrested and taken to the Leon County Detention Facility.

Then, around 8:30 P.M., the S.P.I.D.E.R. Unit was back at it. They located and arrested Da'Quan D. Pittman, wanted out of St. Lucie County for numerous warrants, in the 2000 block of Continental Avenue. Pittman warrants included three counts of Attempted Second Degree Murder.

The Leon County Sheriff's Office Real Time Crime Center (RTCC) assisted the S.P.I.D.E.R. unit with both of these cases
