Putnam Drive Search Warrant Nets Drugs and Guns

Yesterday, members of the Leon County Sheriff's Office Narcotics Unit, assisted by the SWAT Team, served a search warrant on a residence in the 400 block of Putnam Drive. The search warrant was the result of an on-going narcotics investigation into illegal drug sales.

During the search warrant, detectives seized approximately 410 grams of SPICE, crack cocaine, powder cocaine, MDMA, Alpha-PVP, cannabis and 20 Clonazepam pills. In addition to the illegal narcotics, several firearms were also seized; AR-15 rifle, AR-15 pistol along with magazines and ammo, a stolen HK 9mm handgun, a FN 9mm handgun and a Glock 17 handgun with a 30 round magazine.

Detectives arrested Darrel Johnson 25, Tremayne Rumph 21, Brenton Hale 26, Quinerry Hale 22, Henry Brown 33, and Antonio Rhodes 48. All subjects were transported to the Leon County Detention Facility without incident.

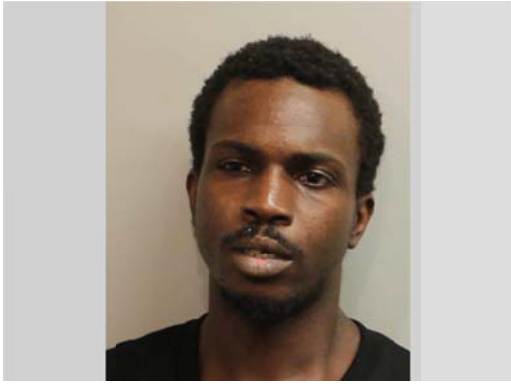
