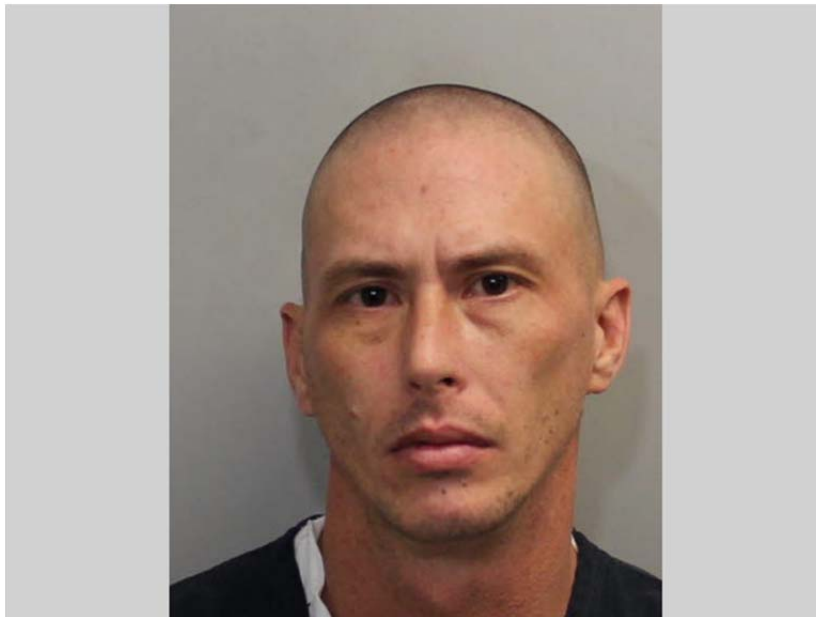
**UPDATE:** LCSO Makes Arrest for the Homicide of Tiffany Nance

**UPDATE:** Detectives from the Leon County Sheriff's Office Violent Crimes Unit have arrested Bryon Heath Massey 38, for the murder of Tiffany Nance.

Today, detectives received information from the Florida Department of Law Enforcement stating that DNA evidence located at the crime scene positively matched Bryon Massey. Detectives then discovered Massey had been wearing a GPS monitor around the time of the homicide. The information from the GPS monitor shows Massey was at the crime scene on January 28, 2017 and then returned to the scene on January 30, 2017.

Massey was already in the Leon County Detention Facility on other charges.

In the early morning of January 29, 2017, a local hunter was walking through an area in the Ochlocknee River Wildlife Management Area. While walking he found Tiffany Nance 33, deceased in a wooded area. An autopsy has been completed and the LCSO Violent Crimes Unit is investigating this as a homicide.
