LCSO Narcotics Unit Arrests Three in Drug Investigation

Last week, the Leon County Sheriff's Office Narcotics Unit, with assistance from the LCSO SPIDER (Special Projects Investigations Detection Enforcement Response) Unit, executed a residential search warrant in the 1200 block of Springsax Road, concluding a lengthy investigation. Before the execution of the search warrant, deputies observed 29-year-old Carlos Grandison and 26-year-old Darrel Grandison inside a vehicle outside the residence. Carlos Grandison exited the vehicle and was found to be in the residence, along with 47-year-old Dexter Davis, when deputies served the search warrant.

During the search, deputies located and seized the following: 70 grams of marijuana, 4.96 grams of crack cocaine, 15 grams of suspected synthetic cannabis, a 9mm handgun, and a loaded magazine.

Darrell Grandison was found to be in personal possession of 9.71 grams of suspected synthetic cannabis, 4.71 grams of alpha PVP (flakka), .2 grams of MDMA, 3.2 grams cocaine, and 5.64 grams of crack cocaine.

All suspected narcotics field tested positive.

All three suspects were arrested and transported to the Leon County Detention Facility.
